Dear Agents,

U.S. Customs & Border Protection (CBP) released a new rule regarding all incoming seashipments to the United States, which becomes operative on 2nd of Februay 2009.

The new "Importer Security Filing" named ISF, also known as "10+2" requires importers and carriers to electronically submit additional data to CBP 24 h in advance to the cut off day or CY container yard closeout of the container which should be shipped.

The purpose of the ISF is, to have a transparent supply chain which could be traced back by the day of loading.

Following additional data elements are needed:

- 1. Reference #
 - Ongoing nonrecurring number assigned by the Moving company
- 2.1. Importer of Record / FTZ ID

Passportnumber, country of issuance, date of birth of the customer

- 2.2. Importer Bond Holder
 - Not applicable
- 3. House Bill of Lading Number

"lowest" level of Bill of Lading number

- 4. Seller name and address
 - Consignee/Owner's name and last foreign address
- 5. Buyer name and address
 - Consignee/Owner's name and new address in the United States
- 6. Consignee number

- 9. **Container Stuffing Location and address** Physical address where the goods were stuffed into the container. Either customers last foreign address or loading address of Moving Company.
- 10. Consolidator name and address Name and address of the party who stuffed the container of arranged for stuffina
- 11. **Commodity HTSUS number** Fill in 980400 for Household Goods

Additionally following data have to be provided by the ocean carrier:

The Import data must be provided by the Importer or Carriers, therefore attached form need to be completed, 24 hours in advance to the cut off day or CY container yard closeout of the container which should be shipped. Please attach the completed form as an scanned document and email it to following email address:

The ISF-Data will be transmitted directly via Automated Manifest System (AMS) or Automated Broker Interface (ABI) to the CBP.

Therefore we will charge a fee of US \$ 35.00 which will be included on the final invoice for the destination service.

This rule doesn't apply for airfreight shipments, however it does apply for diplomatic and foreign military shipments.
